4.1. The Administrator does not share your personal data with other entities, except:

7. Your data will not be transferred to a third country or international organization;8.1 You have the right to;

a) Access - to obtain confirmation from the administrator as to whether or not your personal data are being processed. If the data are processed, You are you are entitled to access them and obtain the following information: about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the data have been or will be disclosed, the period of data storage or the criteria for their determination, the right to request corrigendum, removal or reducing of processing of personal data of the data subject, and to object to such processing;

b) obtain the copy of the personal details – obtain the copy of the personal details that are being processed, while the first copy is always free of charge, and for the next copies the administrator may impose a reasonable charge; resulting from the administrative costs;

c) corrigendum - request for the corrigendum of Your personal data, that are incorrect or to complete the incomplete data;

d) removal of the data – request to remove Your personal data if the administrator does not żądania usunięcia Pani / Pana danych osobowych, jeżeli

11. The data comes from the data subjects;

12. Your provision of personal information is voluntary.
