

Terms and Conditions of the “Flash Sale -40% 2026” Promotion

§ 1

General Provisions

1. These terms and conditions (hereinafter the “Terms and Conditions”) set out the rules of the “Flash Sale -40% 2026” promotion, conducted in the online store www.carpatree.com operated by Carpatree sp. z o.o. (hereinafter also the “Promotion”).
2. For the purposes of these Terms and Conditions, the following terms shall have the meanings assigned to them below:
 - a. Customer - an entity wishing to take advantage of the Promotion.
 - b. Seller/Organiser - Carpatree sp. z o.o., with its registered office at ul. Czajkowskiego 15, 43-300 Bielsko-Biała, tax identification number (NIP) 547-222-12-25.

§ 2

Duration and Territory of the Promotion

1. The Promotion takes place within the territory of the Republic of Poland.
2. The Promotion will run from 8 September 2026 to 10 September 2026 (hereinafter the “Promotion Period”).
3. The Organiser reserves the right to suspend and restart the Promotion at any time. Whether the Promotion is active at a given time is indicated by the information bar at the top of the website www.carpatree.com or by other communications from the Organiser.
4. The Promotion is deemed to start when information that it is running is published, and to end when that information is removed. This information is visible at the top of the page throughout the entire shopping process.

§ 3

Rules of the Promotion

1. The Promotion is intended for Carpatree customers making purchases at www.carpatree.com during the Promotion Period.
2. Terms of the Promotion:
 - a. The Promotion allows customers to use a discount code that reduces the order value by 40%, provided that the minimum basket value specified in the terms of the relevant code is reached.
 - b. The discount code to be entered in the appropriate field in the basket is: FLASH40.
 - c. The minimum basket value required for the discount to apply is PLN 100.

- d. The Promotion applies to all products except products in the Outlet, accessories and tickets categories, and Gift Cards, unless otherwise specified in the terms of the particular code.
- e. The discount code must be entered in the appropriate field in the basket before proceeding to checkout. If the discount code is not applied before the order is paid for, the Promotion will not be applied.
- f. The Promotion may be combined with other promotional offers only where this is expressly permitted in the terms of the relevant promotion.

§ 4

Returns Policy

- 1. If one or more products from an order covered by the Promotion are returned, the Customer will receive a refund of the amount actually paid for the returned product (i.e. after the discount under the Promotion has been applied).
- 2. Returning part of an order does not result in the loss of entitlement to the discount applied to the remaining products in the order.
- 3. All returned products must show no signs of use and must meet the other conditions set out in the Store Terms and Conditions.
- 4. Returns of entire orders are handled in accordance with the rules set out in the Store Terms and Conditions.

§ 5

Final Provisions

- 2. Participation in the Promotion constitutes acceptance of these Terms and Conditions.
- 3. Matters not covered by these Terms and Conditions shall be governed by Polish law.
- 4. Any disputes arising from the performance of obligations related to this Promotion shall be settled by the court of general jurisdiction with territorial jurisdiction over the Organiser’s registered office.

- 6. These Terms and Conditions enter into force on 8 September 2026.
