# RUNMAGEDDON

## DECLARATION OF THE LEGAL GUARDIAN OF A MINOR PARTICIPANT

I, .....  
(name and surname, id card number or PESEL)

hereby declare that:

1. I am the Legal Guardian of a minor .....  
PESEL .....(hereinafter referred to as the Participant) and I have full legal capacity, and consequently I consent to the Participant taking part in the RUNMAGEDDON run. I am not inebriated, under the influence of alcohol or other substances (e.g. medicines, psychotropic or stimulating substances), which could in any way affect or limit my psychomotor performance and the ability to take decisions.
2. The state of health of the Participant fully enables taking part in the RUNMAGEDDON ..... \* run on ..... (day of the run).
3. During the RUNMAGEDDON run, the Participant undertakes to follow all orders and instructions received from the organizers and volunteers as well as medical and emergency services.
4. The Participant takes part in the RUNMAGEDDON run at his/her own request and risk, in order to put his/her body to the test. I am aware that the RUNMAGEDDON run is an event of heightened risk, during which the Participant may sustain cuts, injuries, including abrasions, sprains, dislocations, bruises, and fractures, as well as bites, chills and all kinds of inconveniences related to the nature of the run and I declare that I shall personally bear sole responsibility for their occurrence.
5. I shall be fully and exclusively responsible for all possible injuries caused by the Participant to anyone during, as a result of or in connection with his/her participation in the run.
6. In the event of any injury suffered by the Participant, neither the Participant nor I shall bring any claims in this respect against the Organizers, their associates and volunteers working during the RUNMAGEDDON run. I hereby release the Organizers, their associates, and volunteers from all liability for injuries suffered by me and the Participant, which are related to his/her participation in the RUNMAGEDDON run.
7. The data and statements I provide are completely true. No information about the Participant's health, which is important from the point of view of the Participant's safety during the RUNMAGEDDON run, has been omitted or concealed by me.
8. Any disputes arising from this declaration, as a result of or in connection with participation in the RUNMAGEDDON run shall be resolved by a common court law with general jurisdiction.
9. I have read and I accept the regulations of the RUNMAGEDDON series of runs (<https://www.runmageddon.pl/regulaminy>).
10. I have been informed about the right to leave handheld items with a value not exceeding PLN 500 on deposit. I have read the terms of the deposit and accept them (<https://www.runmageddon.pl/regulaminy>).
11. I agree to the free of charge publication by the Organizers, sponsors and official partners whose list can be found on the Website of the Organizers, of the Participant's image recorded in the form of photographs or video recordings. This publication may take place in relation to the event, as well as in all promotional materials of the RUNMAGEDDON series of runs, including those posted on websites, in the media and social media.
12. I represent that I consent to the processing of my personal data and the personal data of the Participant for the purpose of the organization of the RUNMAGEDDON run by Extreme Events Sp. z o.o. with registered office in Warsaw in accordance with the provisions of mandatory legal regulations.
13. I am aware that the participants of the RUNMAGEDDON run will be filmed using a drone whose pilot has the knowledge and technical means to carry out such flights safely. Due to the possibility of making a mistake by the pilot or a failure of the drone, I will be very careful and will not touch or approach the drone. The Participant undertakes to do the same. In the event of the drone falling, the Participant will protect his/her head.
14. *(does not apply to the KIDS, MICRO, JUNIOR and INTRO formula)*: I undertake, on behalf of the Participant, to hand over the chip used to measure time at the finish line of the RUNMAGEDDON run. I am aware that the fee for a lost chip is PLN 20. In the event of not completing or not starting the run (after receiving the package), the chip should be returned to the competition office or at the finish line.
